


Customer Challenges

- Self service data acquisition time to value






Abstraction layer to share and use data across a hybrid cloud landscape






- Leaves data where it lives and apply intelligent automation to govern, secure and bring AI to your data

- Enables self-service data access to support various applications, analytics, and use cases


Unified Data Fabric

Structured Data Inspection and Classification


- Analyze data in columns and label columns
- Default labels (business terms) and custom business terms









Policy Engine – Create rules that control who can access what data

Rule:

If usergroup contains public access

And dataclass PartNum is found

Then
Restrict access


- Access Control Deny access to the asset (table, column, file, object)
 - Use Access control lists (ACLs) such as NFSv4, SMB, S3 Bucket policies and ACLs for unstructured data
- Redact, Obfuscate, mask




Customer Example – Export Control Compliance
