#### Industry impact

To use our vendor neutral technology expertise to influence international standards, make sense of legislation, and provide access to best practice and education on Data Protection and Privacy issues.

#### Industry segment relevance

- ISO/IEC 27040:2024 Information technology Security techniques Storage security (in progress) contains 'shall' statements for the first time. This means it will be used as a conformance standard to hold storage vendors to account.
- IEEE 2883-2022 standard on data sanitization has impact on the way data are eradicated prior to reuse or disposal of storage technology.
- 44% of CEO respondents rank Data Privacy among the top 3 policies most impactful to their business (PWC).
